Directions to Match: CCDTC is located in Miami Township (near Milford) on Route 50 just east of I-275. The address is 6058 Kells Lane, Milford, OH 45150. Take the Route 50/Hillsboro exit off of I-275 turn towards Route 50/Hillsboro (not towards Milford Parkway) and then turn right (east) on Route 50. Travel approximately 2 ½ miles through three traffic lights. After the third traffic light (Round Bottom Road, UDF on corner) continue on Rt. 50 until you come to the second street, Kells Lane, just past Sugar Camp. Turn left on Kells Lane. The building is the first building on the right that faces Kells Lane. The property adjoins Cincinnati Riding for the Handicapped. Note that Kells Lane **does not** appear on GPS devices.
